Key Purpose of Job

Under the reasonable direction of the Headteacher, carry out the professional duties of a school teacher as set out in the current School Teachers' Pay and Conditions Document (STPCD).

Develop teaching and learning within Maths.

Support, guide and motivate teachers of the subject and other adults e.g. teaching assistants, administrative and technical staff promoting a positive staff culture, good practice and continuing professional development.

Develop opportunities to share ideas and strategies that impact classroom learning.

Take a lead role in planning collaboratively with the other specialist subjects.

Liaise with partner schools to provide support for staff and curriculum opportunities for pupils.

Prepare and deliver Inset which could include organising conferences on teaching and learning.

Support teachers across the school to improve teaching



1.Strategic Direction

- Take a leading role in the development of policy and practice to support the continued improvement of effective teaching and learning in the Maths department and across the school.
- Analyse and interpret relevant data, research and other documentation to inform future practice, expectations and teaching methods.
- Contribute to monitoring the progress made in implementing subject plans and achieving targets, evaluate the effect on teaching and learning, and use this analysis to guide further improvement.
- Contribute to students' spiritual, moral and cultural development

4. Teaching

- To teach students according to their educational needs, including the setting and marking of work to be carried out by the student in school and elsewhere.
- To assess, record and report on the attendance, progress, development and attainment of students and to keep such records as are required.
- To provide, or contribute to, oral and written assessments, reports and references relating to individual students and groups of students.
- To ensure that ICT, Literacy, Numeracy and school subject specialism(s) are reflected in the teaching/learning experience of students.
- To undertake a designated programme of teaching.
- To ensure a high quality learning experience for students which meets internal and external quality standards.
- To prepare and update subject materials.
- To use a variety of delivery methods which will stimulate learning appropriate to students' needs and demands of the syllabus.
- To maintain discipline in accordance with the school's procedures, and to encourage good practice with regard to punctuality, behaviour, standards of work and homework.
- To undertake assessment of students as requested by external examination bodies, departmental and school procedures.
- To mark, grade and give written/verbal and diagnostic feedback as required.

3. Academic Oversight:

- Track, monitor, and analyse the academic performance of the year group, identifying trends and taking action where necessary.
- Work with subject teachers to ensure students are receiving appropriate support in their learning.
- Use data effectively to target students who require additional intervention, including those who are high-achieving or need more challenges.

5. Operational/ Strategic planning



- To assist in the development of appropriate syllabuses, resources, schemes of work, marking policies and teaching strategies in the Curriculum Area and Department.
- To contribute to the Curriculum Area and department's development plan and its implementation.
- To plan and prepare courses and lessons.
- To contribute to the whole school planning activities.

6. Curriculum provision

• To assist the Head of Department, the SMT, to ensure that the curriculum area provides a range of teaching which complements the school's strategic objectives.

7. Curriculum development

• To assist in the process of curriculum development and change so as to ensure the continued relevance to the needs of students, examining and awarding bodies and the school's Mission and Strategic Objectives.

8. Staffing

- To take part in the school's staff development programme by participating in arrangements for further training and professional development.
- To continue personal development in the relevant areas including subject knowledge and teaching methods.
- To engage actively in the Appraisal process.
- To ensure the effective/efficient deployment of classroom support.
- To work as a member of a designated team and to contribute positively to effective working relations within the school.

Quality assurance

- To help to implement school quality procedures and to adhere to those.
- To contribute to the process of monitoring and evaluation of the curriculum area/department in line with agreed school procedures, including evaluation against quality standards and performance criteria. To seek/implement modification and improvement where required.
- To review from time to time methods of teaching and programmes of work.
- To take part, as may be required, in the review, development and management of activities relating to the curriculum, organisation and pastoral functions of the school.
- To support teachers within Maths and across the school to improve their pedagogy.

9. Management information

- To maintain appropriate records and to provide relevant accurate and up-to date information for MIS, registers, etc.
- To complete the relevant documentation to assist in the tracking of students.
- To track student progress and use information to inform teaching and learning.



10. Communications and liaison

- To communicate effectively with the parents of students as appropriate.
- Where appropriate, to communicate and co-operate with persons or bodies outside the school.
- To follow agreed policies for communications in the school.
- To take part in liaison activities such as parents' evenings, review days and liaison events with partner schools.
- To contribute to the development of effective subject links with external agencies.

11. Management of resources

- To contribute to the process of the ordering and allocation of equipment and materials.
- To assist the Head of Department to identify resource needs and to contribute to the efficient/effective use of physical resources.
- To co-operate with other staff to ensure sharing and effective usage of resources to the benefit of the School, department and the students.

12. Pastoral system

- To be a Form Tutor to an assigned group of students.
- To promote the general progress and well-being of individual students and of the Form Tutor Group as a whole.
- To liaise with a Pastoral Leader to ensure the implementation of the school's Pastoral System.
- To register students, accompany them to assemblies, encourage their full attendance at all lessons and their participation in other aspects of school life.
- To evaluate and monitor the progress of students and keep up-to-date student records as may be required.
- To contribute to the preparation of action plans and progress files and other reports.
- To alert the appropriate staff to problems experienced by students and to make recommendations as to how these may be resolved.
- To communicate as appropriate, with the parents of students and with persons or bodies outside the school concerned with the welfare of individual students, after consultation with the appropriate staff.
- To contribute to PSHE and citizenship and enterprise according to school policy.
- To apply the Behaviour Management systems so that effective learning can take place.

13. School ethos

- To play a full part in the life of the school community, to support its distinctive mission and ethos and to encourage staff and students to follow this example.
- To support the school in meeting its legal requirements for worship.
- To actively promote the school's corporate policies.



- To comply with the school's Health and Safety policy and undertake risk assessments as appropriate.
- To perform such other duties as may be required from time to time by the Head Teacher.

Leadership

To fully contribute to operational leadership of the college through supporting with duty points before after and during the school day and also contributing to the effective running of whole school events

- a) To undertake additional duties as required, commensurate with the level of the job.
